



NYU has a preferred agreement with Avis Rent A Car System, Inc. for both University business & personal use, for car rentals in the 48 contiguous states, Puerto Rico and the District of Columbia. (Alaska, Hawaii and Canada are not included in this agreement). Rental reservations can be made directly with Avis by calling # 1-800-331-1212, or going on to the Avis website at www.avis.com. When booking on the web, you must select the Corporate Rate under Rates & Discounts, in order to receive the NYU corporate rate and benefits. Do not select the lowest rate or promotional rate option.

When you visit Avis on the internet to make a reservation you can also apply for the Preferred Renter service. This is free of charge to the employees of NYU. The service allows you to have a profile with Avis to make your renting experience smooth and easy. See also the NYU/Avis website at www.avis.com/AvisWeb/html/bridge/corp/go.html?B686400 for a preferred service application, a free upgrade coupon and other special offers. The site also has maps, pictures and descriptions of the Avis vehicles, and other information. When placing a reservation via phone or through avis.com, remember to use the NYU corporate discount # **B686400** and decline loss damage waiver.

All rates in the United States for compact thru full-size cars include unlimited mileage when picked-up and returned to the same city. In order to receive the NYU discount you must use the AWD# (NYU/Avis Worldwide Discount number) **B686400**, an Avis honored charge card (Visa, MasterCard, Discover, Diners Club, American Express), and show your NYU identification card when you pick-up the vehicle.

When you use the NYU/Avis corporate discount number, for University business or personal use, you are covered for loss and damage to the vehicle and liability insurance (except in Puerto Rico) is provided as long as you are charged the corporate rate. Promotional rates do not include the same insurance coverage.

NOTE: For rentals commencing in Manhattan from 12:01am Friday through 3:00pm Sunday, and for rentals commencing at JFK and LaGuardia and Newark Airports between the hours of 1:00 pm Friday through 3:00 pm Sunday, Current published rates, less a discount will apply.

At Avis Corporate and Participating licensee locations, these corporate rates include Loss Damage Waiver (LDW) for business and personal rentals and unlimited mileage when the car is returned to the renting city. Liability insurance \$100,000/\$300,000 and Property Insurance \$25,000 Coverage is also included. Rates may not be available or maybe blacked out during certain peak demand periods. (LDW & Liability Insurance is included in the corporate rates for the 48 contiguous States, and the District of Columbia).

Weekly rates are calculated at six (6) times the daily rate; monthly rates are calculated at twenty-four (24) times the daily rate.

On those rentals of vehicles not returned to the same city where rented, the above Corporate Rates apply, plus an additional charge of \$0.34 per mile driven.

There will be a \$5.00 surcharge for all one day rentals commencing on Tuesday or Wednesday, from all locations in the United States & Puerto Rico.

INTERNATIONAL RATES

In the following international areas, eligible renters will receive discounts from published commercial rates specified below:

NOTE: Always purchase “all inclusive” insurance from the rental agency in International areas. It is not included in the NYU Corporate Agreement.

REMINDER

Always fill your gasoline tank prior to returning the vehicle to avoid refueling charges.

TERMS AND CONDITIONS

If you choose to rent from Avis under a special promotion or other discount program, terms and conditions of the New York University agreement will not apply.

Rates and discounts will apply to both personal and business rentals, and is available to all NYU employees as long as the AWD# **B686400** (discount #) is in your reservation. Rates are valid at all participating locations with advanced confirmed reservations and are subject to availability of vehicles. Other taxes and/or surcharges may also apply.

All renters are subject to Avis’ standard driver qualifications procedures. The minimum age requirement for renters and co-workers of the same company using a corporate AWD number, at corporate locations, and participating licensees, is 18. Employees of the same company who are traveling together using a corporate AWD number can drive the Avis car based on the same minimum age requirement that determines the renter’s eligibility. A spouse or NYU business renter is not classified as additional driver.
